A QUICK LOOK



Over the past month, the average rental price in the neighborhoods analyzed by this report increased by 0.32%, from \$2,005.38 to \$2,011.77. Studio rental pricing increased by 0.70%, from \$1,670.03 to \$1,681.77. The average rental price for a one-bedroom unit increased by 1.59%, from \$1,927.89 to \$1,958.58. The average rental price for a two-bedroom unit decreased by 0.96%, from \$2,418.22 to \$2,394.96.

Compared to this time last year, the average rental price for a studio in the Bronx is up by 0.24%. One and two-bedroom rental prices are up by 9.41% and 2.80% in that same span. Overall, the average rental price tracked by this report is up 4.00% from this time last year.

This past month, the most expensive studio and one-bedroom rentals were in Mott Haven, while the most expensive two-bedroom rentals were in Riverdale. The most affordable across-the-board were in Morris Heights/University Heights.






BRONX AVERAGE PRICE






BRONX STUDIO PRICE TRENDS OVER 13 MONTHS



BRONX ONE-BEDROOM PRICE TRENDS OVER 13 MONTHS








CONCOURSE / HIGHBRIDGE STUDIO PRICE TRENDS OVER 13 MONTHS



CONCOURSE / HIGHBRIDGE ONE-BEDROOM PRICE TRENDS OVER 13 MONTHS




CONCOURSE / HIGHBRIDGE TWO-BEDROOM PRICE TRENDS OVER 13 MONTHS






MORRIS HEIGHTS / UNIVERSITY HEIGHTS STUDIO PRICE TRENDS OVER 13 MONTHS



MORRIS HEIGHTS / UNIVERSITY HEIGHTS ONE-BEDROOM PRICE TRENDS OVER 13 MONTHS




MORRIS HEIGHTS / UNIVERSITY HEIGHTS TWO-BEDROOM PRICE TRENDS OVER 13 MONTHS


THROUGH APRIL, THE AVERAGE RENTAL PRICE IN MOTT HAVEN HAS DECREASED BY 2.44%.




PRICE TRENDS: RIVERDALE

OVER THE PAST MONTH, THE AVERAGE RENTAL PRICE IN RIVERDALE DECREASED BY JUST 0.29%.


RIVERDALE STUDIO PRICE TRENDS OVER 13 MONTHS

THE REPORT EXPLAINED

THE BRONX RENTAL MARKET REPORT COMPARES FLUCTUATION IN THE CITY'S RENTAL DATA ON A MONTHLY BASIS. IT IS AN ESSENTIAL TOOL FOR POTENTIAL RENTERS SEEKING TRANSPARENCY IN THE NYC APARTMENT MARKET AND A BENCHMARK FOR LANDLORDS TO EFFICIENTLY AND FAIRLY ADJUST INDIVIDUAL PROPERTY RENTS IN BRONX.

The Bronx Rental Market Repor TM is based on a cross-section of data from available listings and priced under \$10,000, with ultraluxury property omitted to obtain a true monthly rental average. Our data is aggregated from the MNS proprietary database and sampled from a specific mid-month point to record current rental rates offered by landlords during that particular month. It is then combined with information from the REBNY Real Estate Listings Source (RLS), OnLine Residential (OLR.com) and R.O.L.E.X. (Real Plus).
