A QUICK LOOK

QUEENS

Through December, the average rental price in Queens decreased by 0.5%, from \$2,667.12 to \$2,653.76. The average rental price for a studio decreased by 0.35%, from \$2,110.24 to \$2,102.84. The average rental price for a one-bedroom unit decreased by 0.01%, from \$2,559.59 to \$2,559.34. The average rental price for a two-bedroom unit decreased by 0.97%, from \$3,331.54 to \$3,299.11.

Out of the eight neighborhoods tracked by this report, three saw their average rental prices increase month-over-month. The remaining areas decreased this month.

Long Island City: -2.2%	Rego Park: -0.3%
Astoria: -2.89%	Forest Hills: -1.98%
Ridgewood: +4.31%	Jackson Heights: -1.01%
Flushing: +0.65%	Jamaica: +0.87%

The most expensive studio, one-bedroom and two-bedroom units by average price were all in Long Island City, while the most affordable studio units were in Flushing, and most affordable one and two-bedroom units were in Jackson Heights.

Year-over-year, studio, one-bedroom, and two-bedroom rental prices are up 12.49%, 11.81%, and 12.88%, respectively, with an overall increase of 12.43% since this time last year.

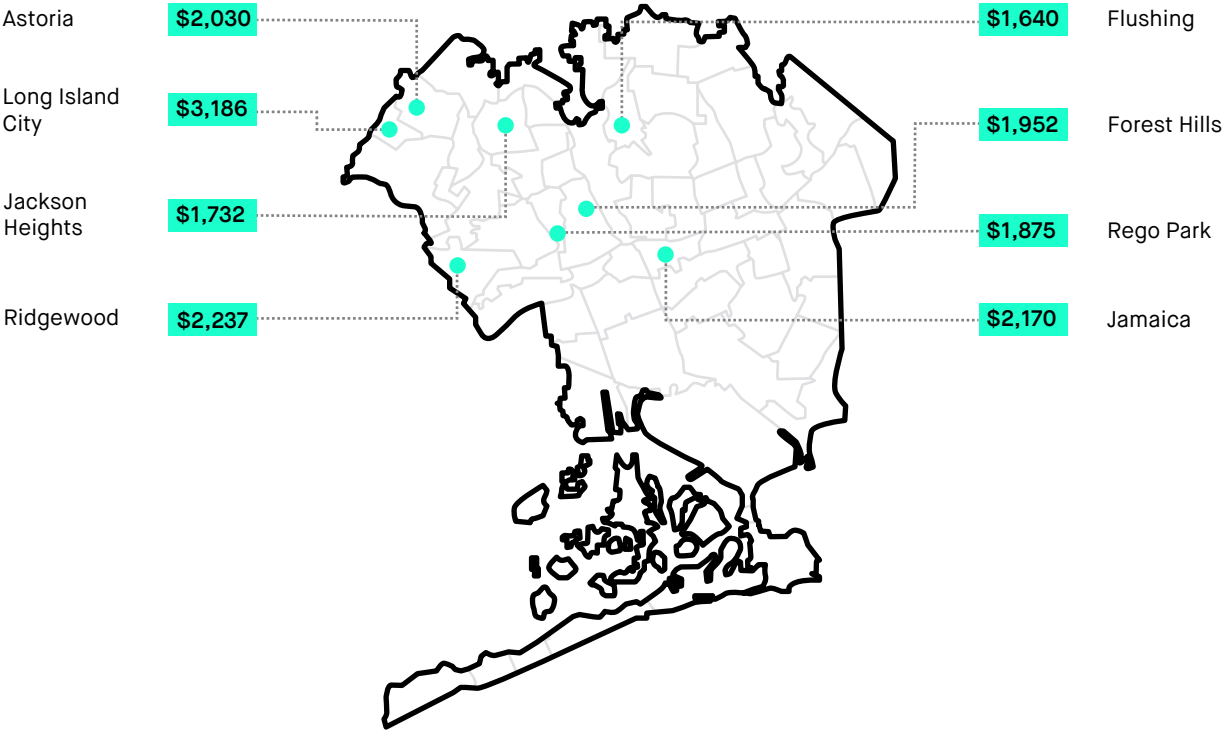

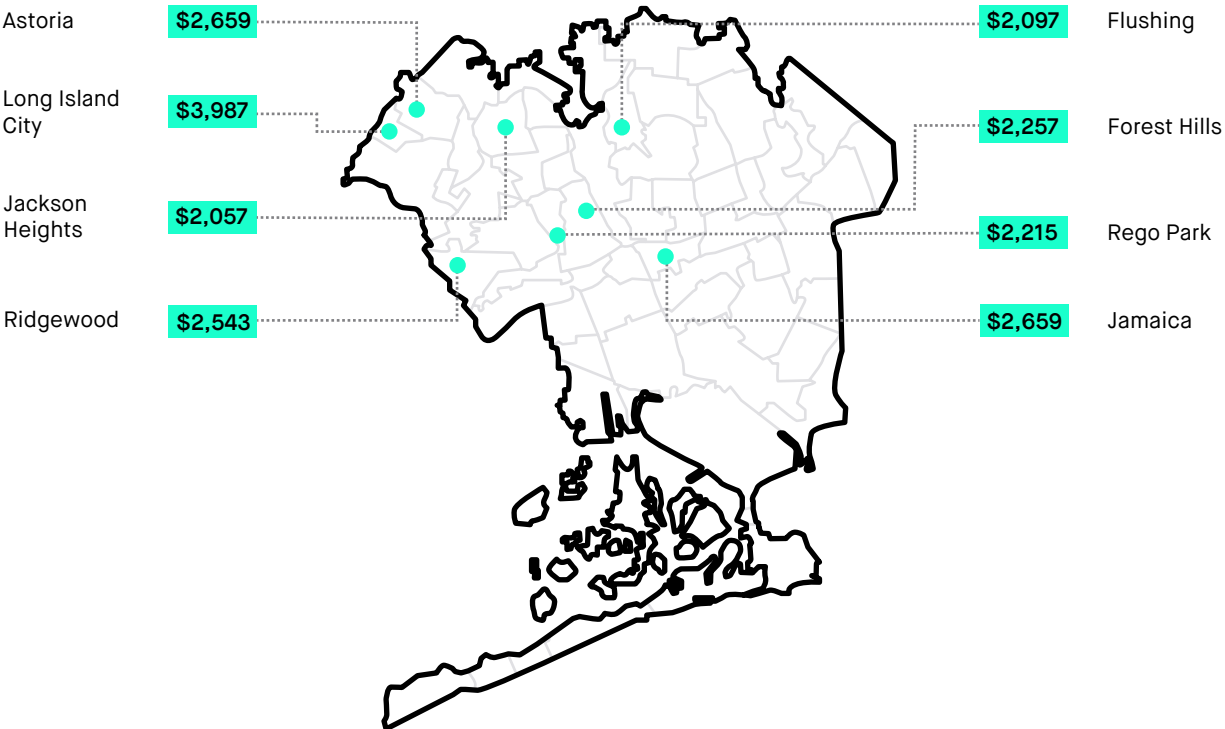

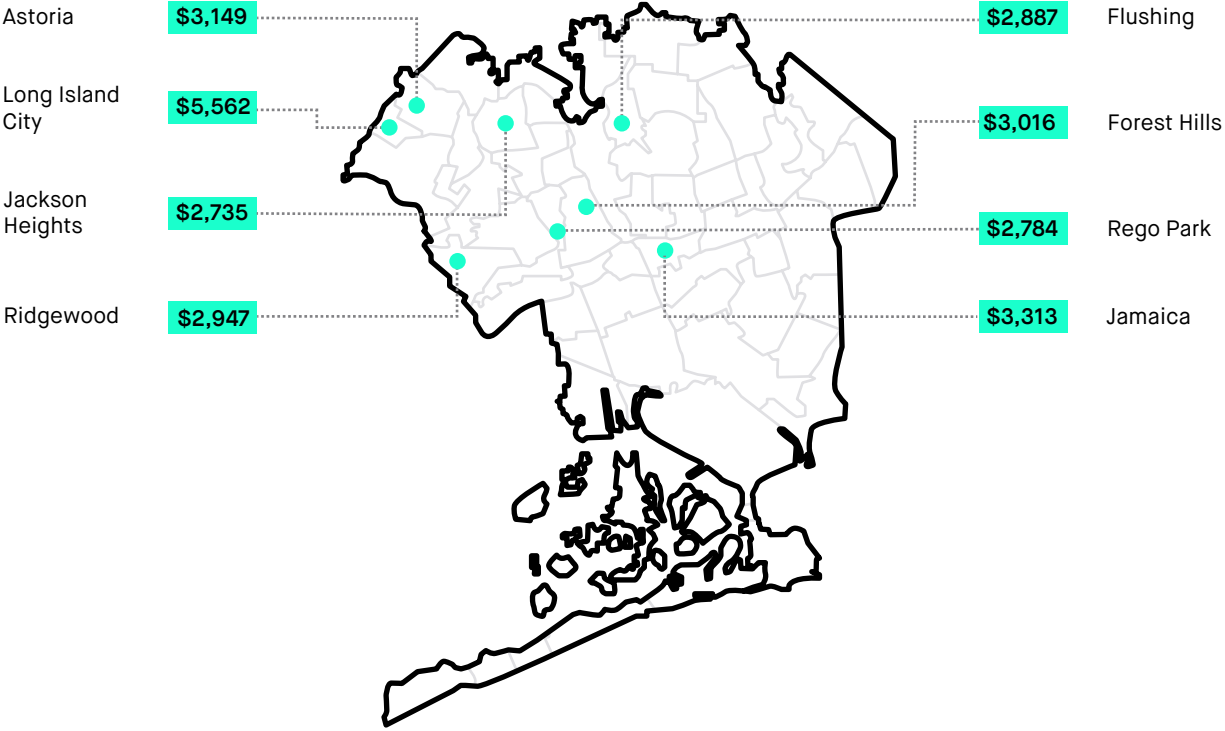

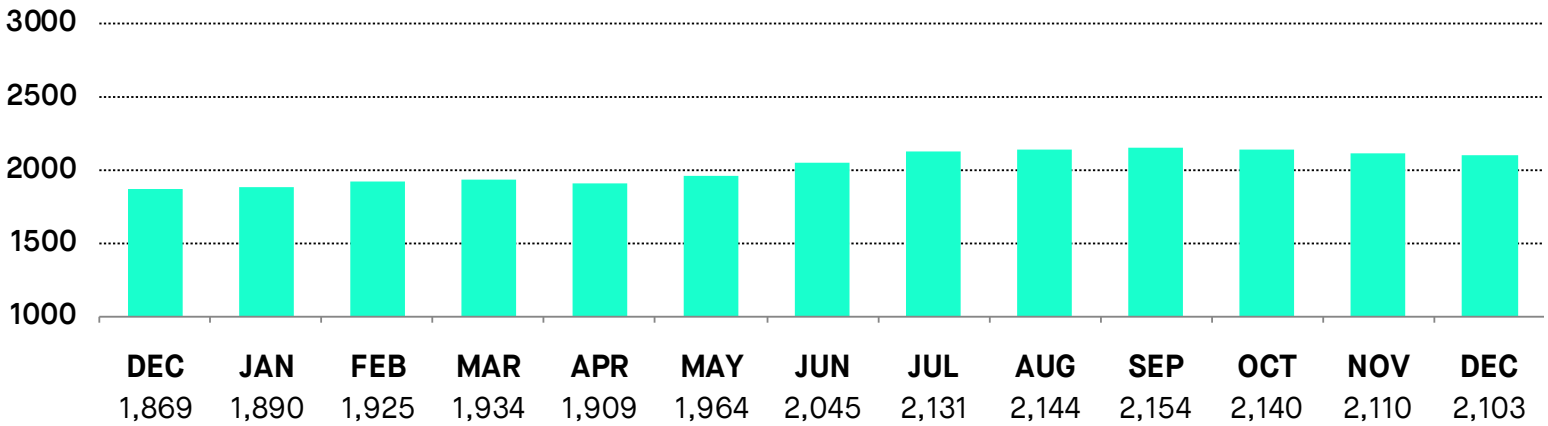

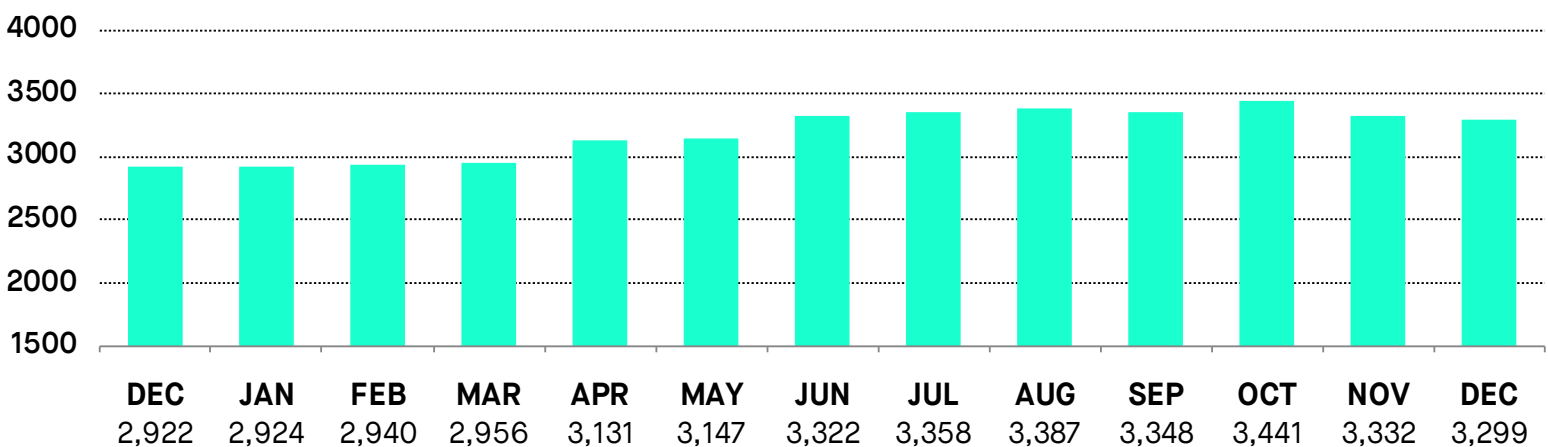
QUEENS STUDIO PRICE TRENDS OVER 13 MONTHS



QUEENS ONE-BEDROOM PRICE TRENDS OVER 13 MONTHS



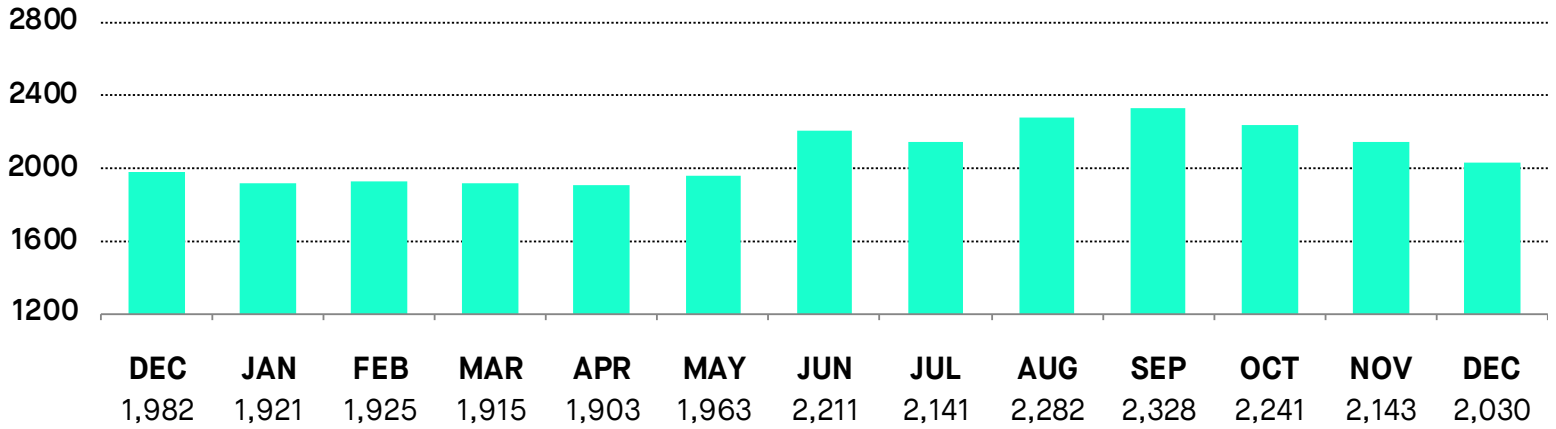

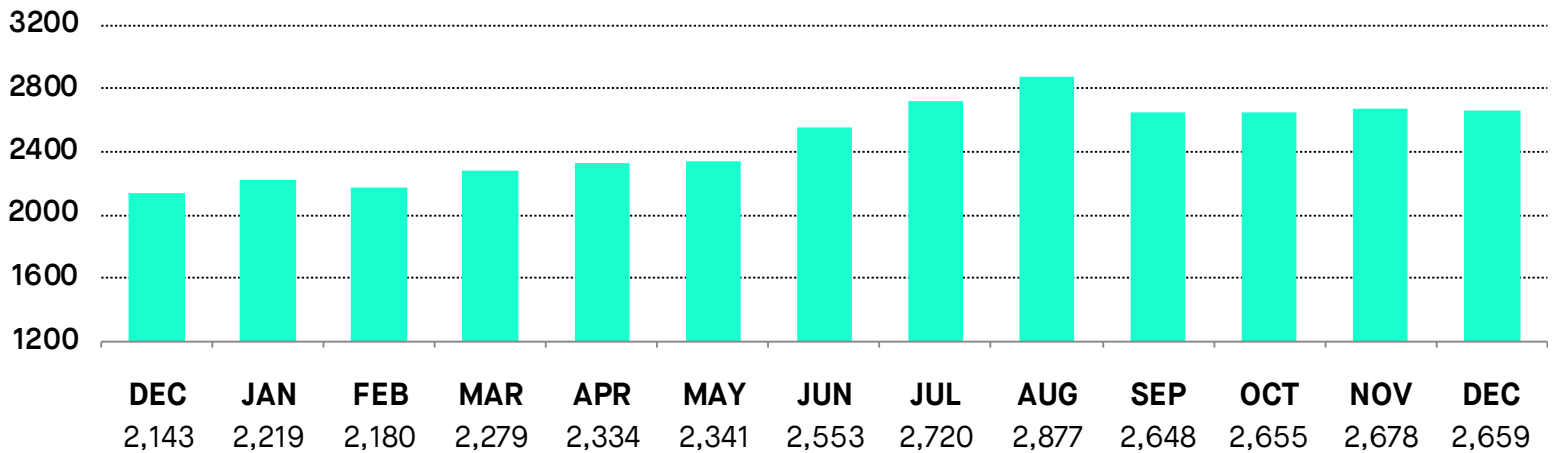

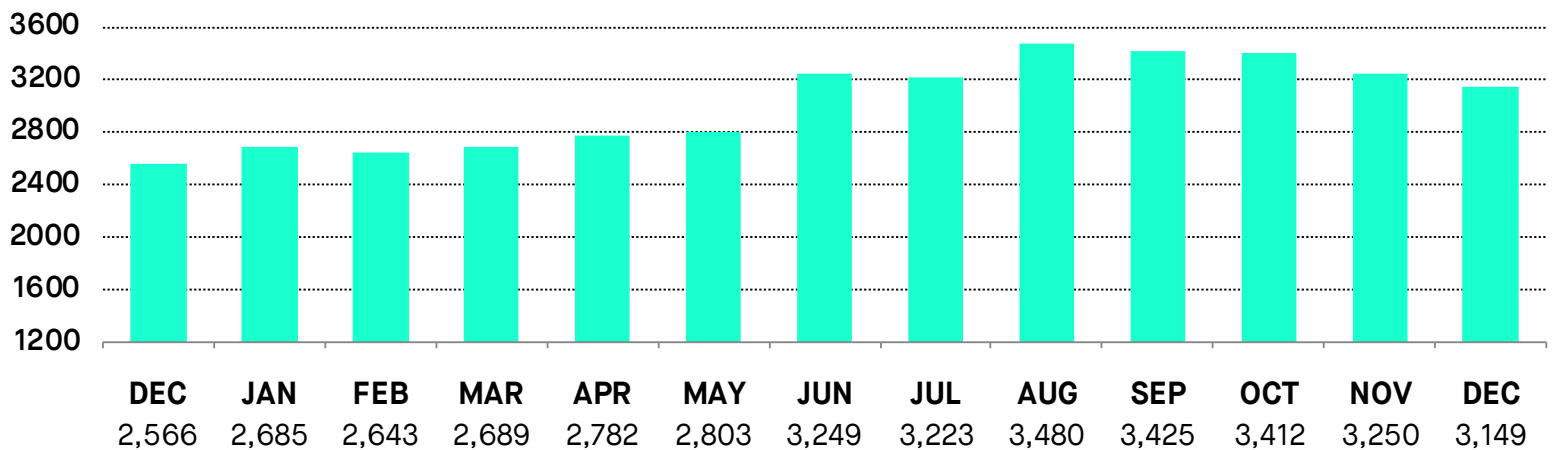
ASTORIA STUDIO PRICE TRENDS OVER 13 MONTHS

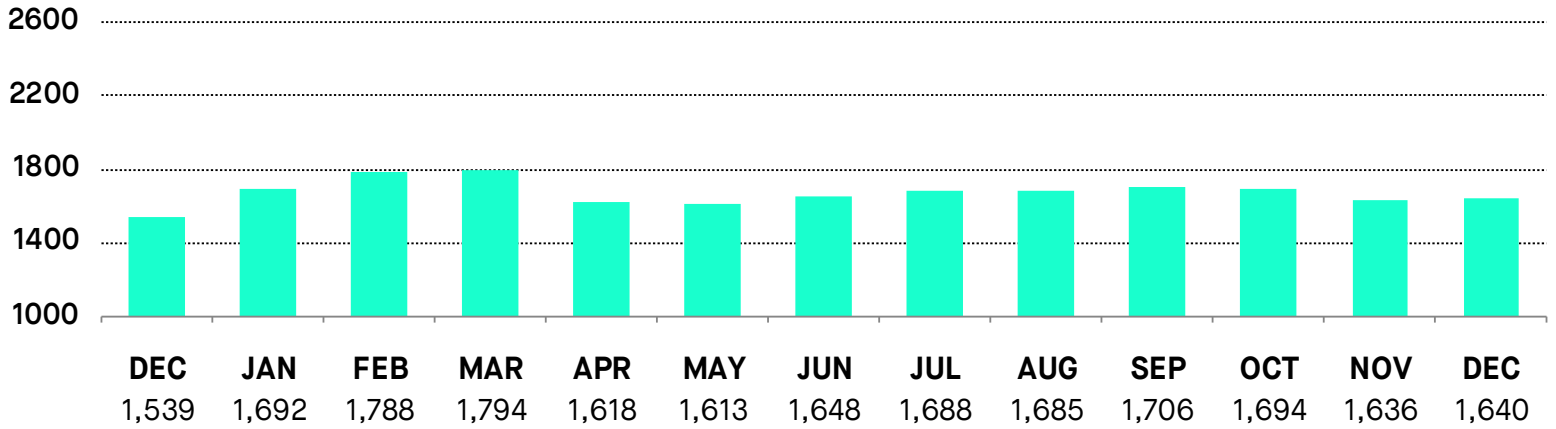

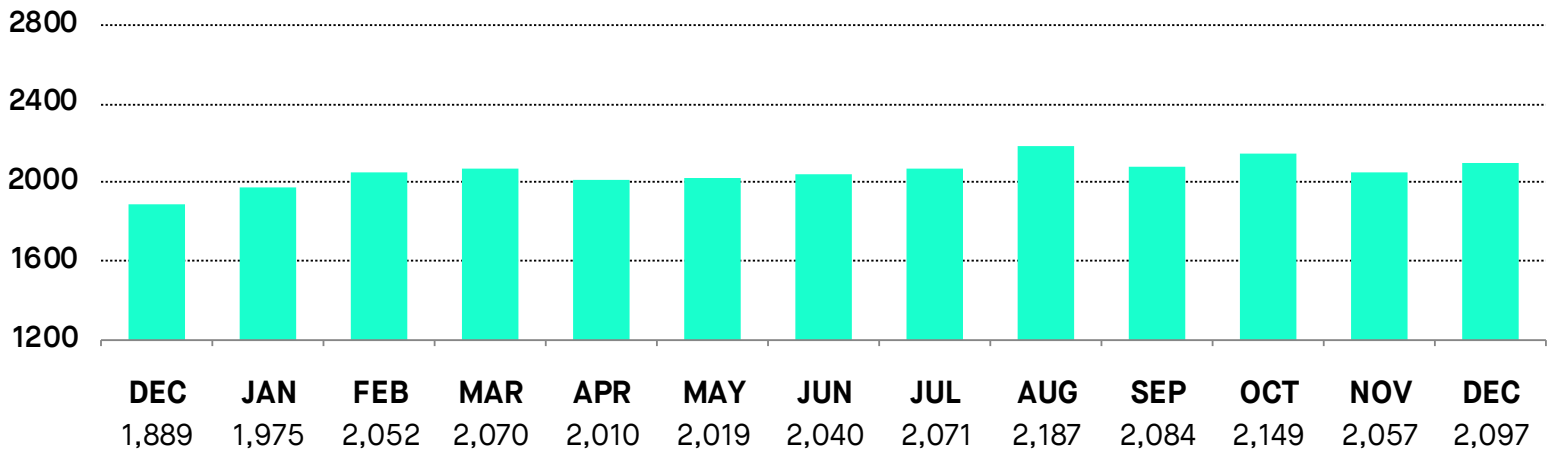

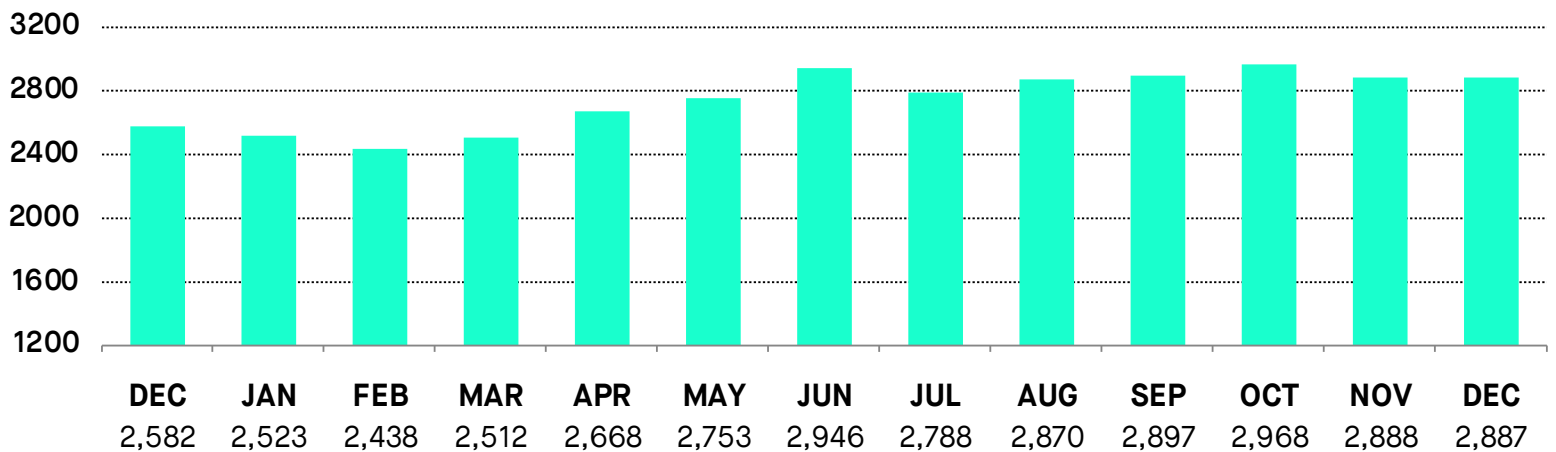
FLUSHING STUDIO PRICE TRENDS OVER 13 MONTHS

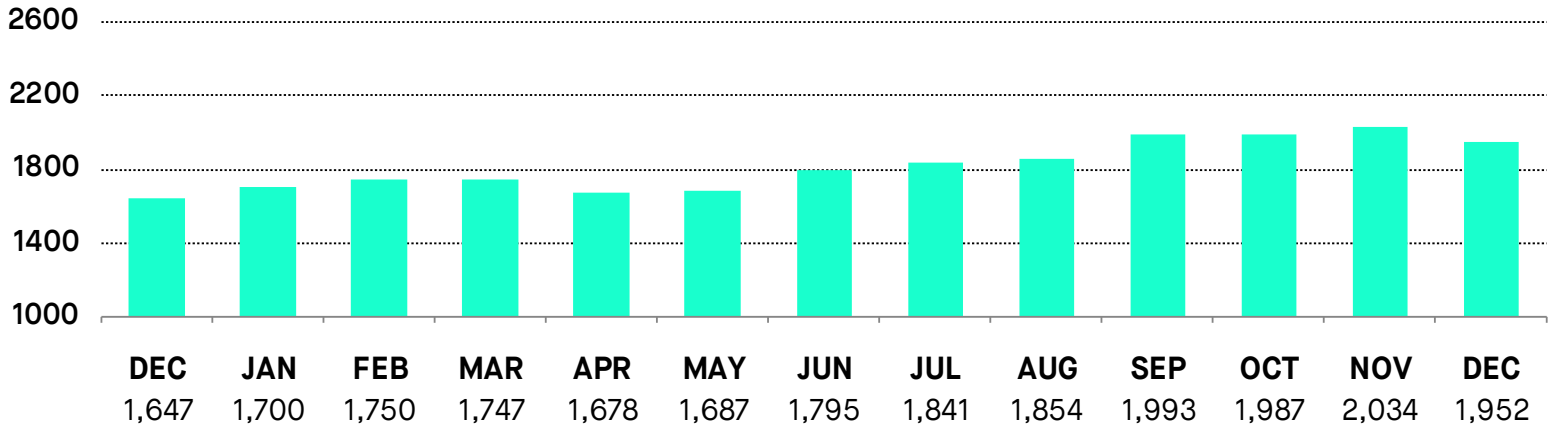

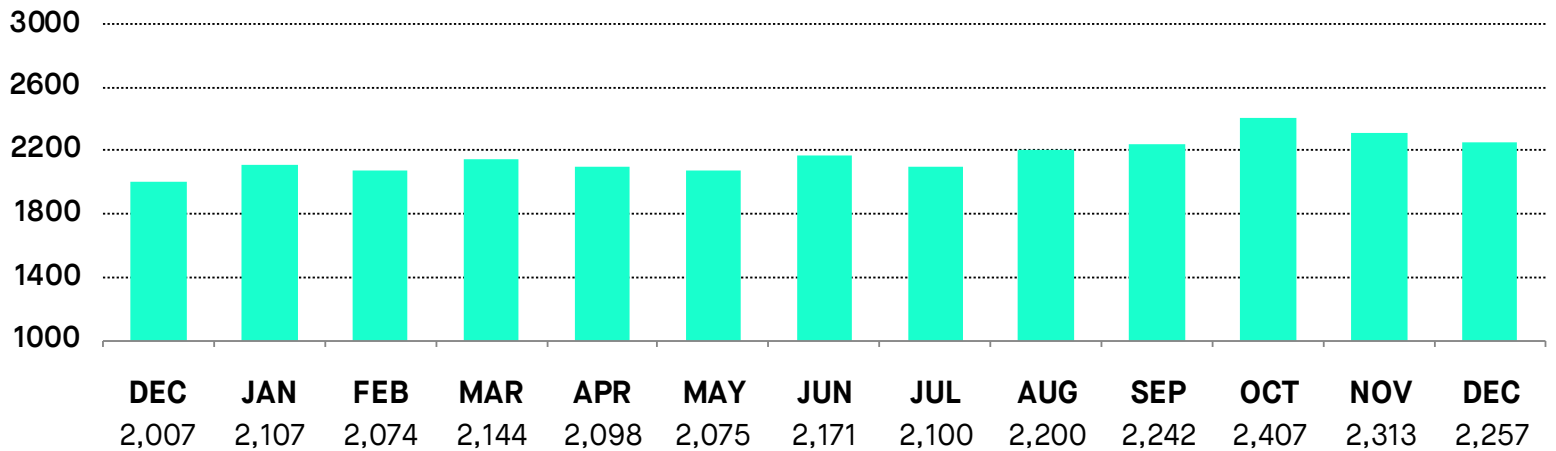

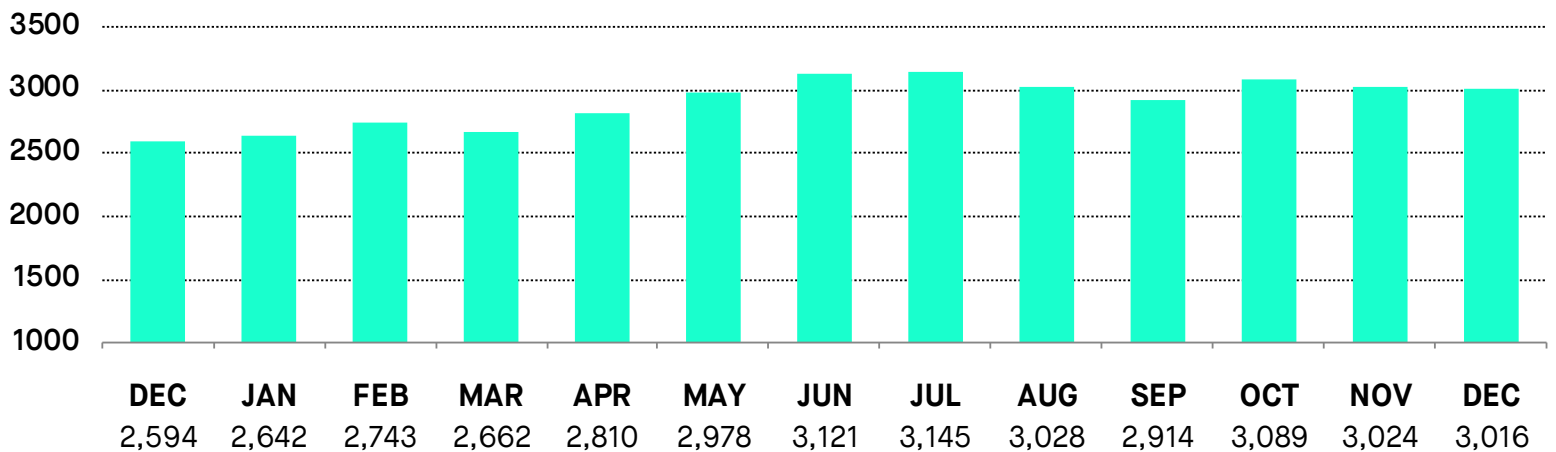
FOREST HILLS STUDIO PRICE TRENDS OVER 13 MONTHS

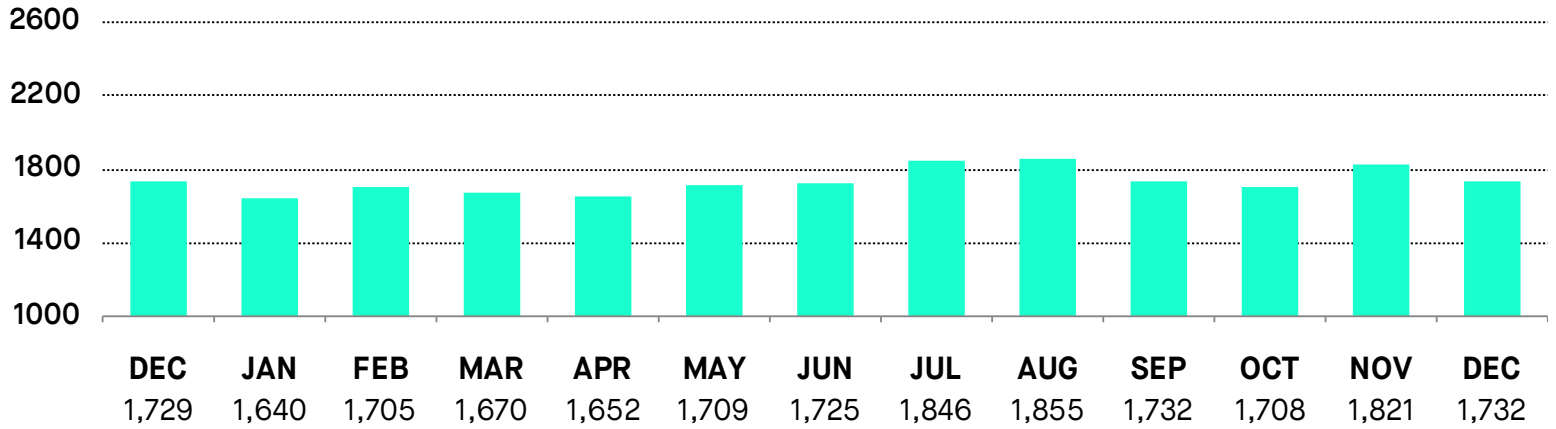

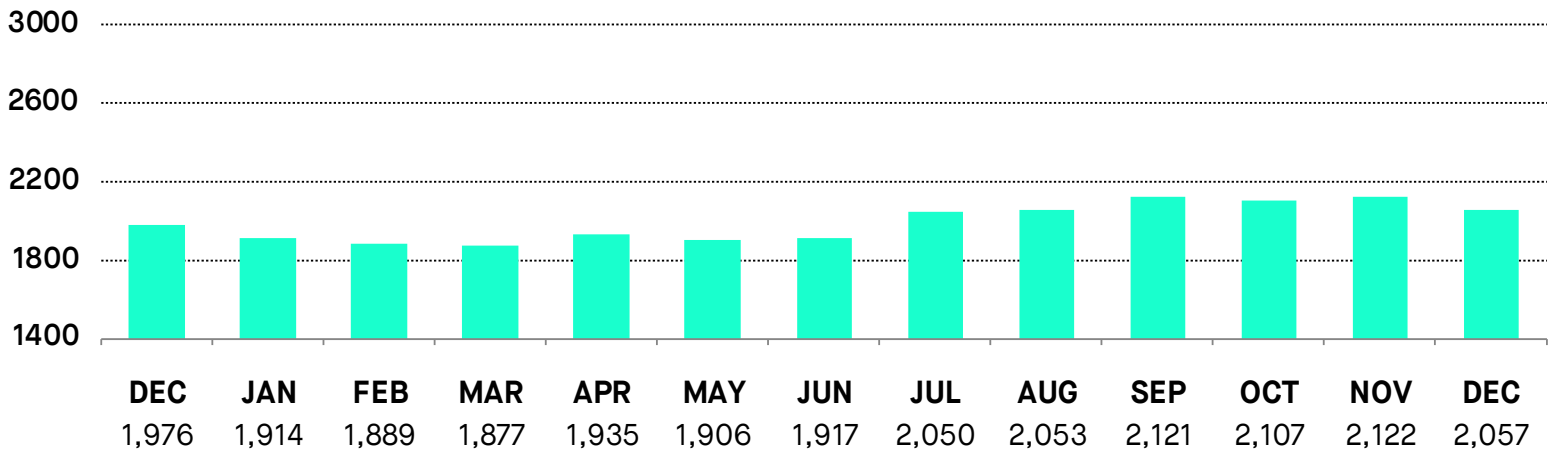

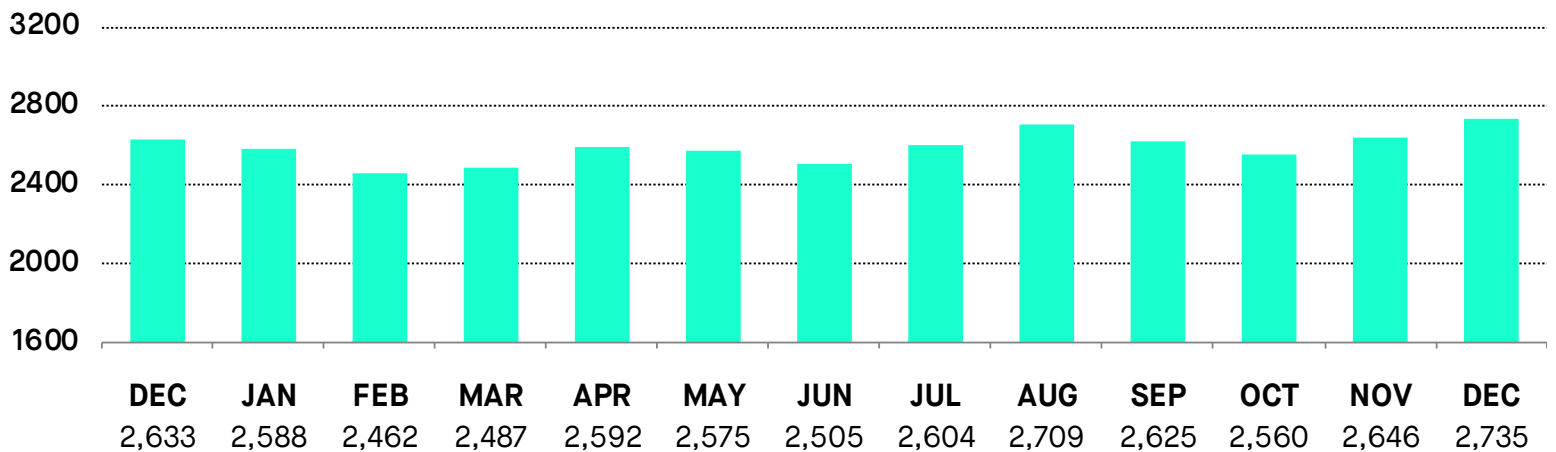
JACKSON HEIGHTS STUDIO PRICE TRENDS OVER 13 MONTHS

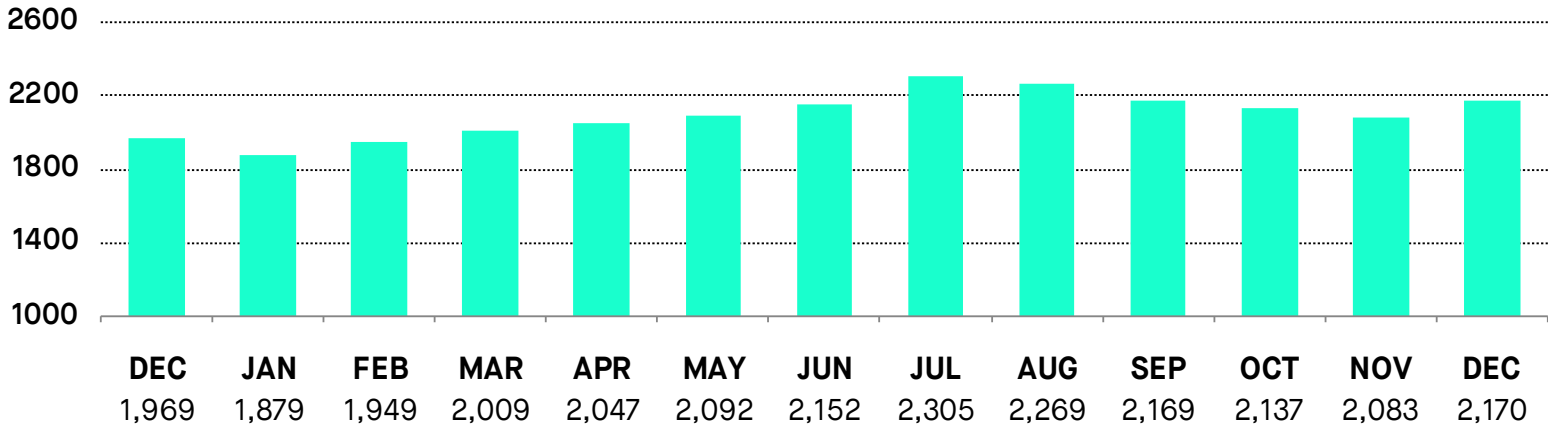

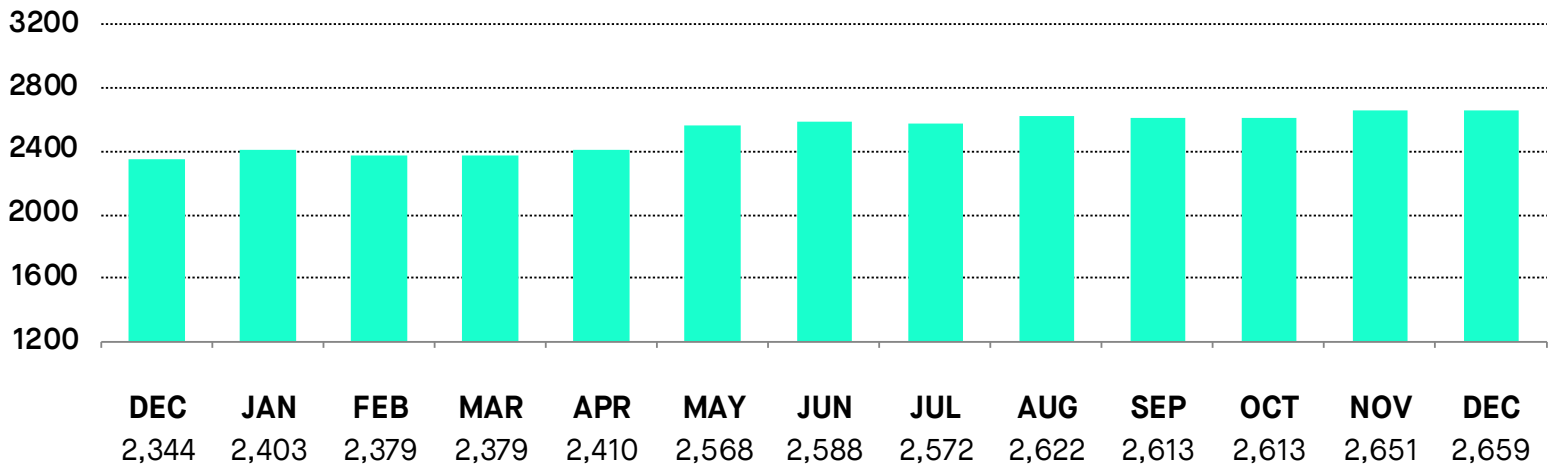

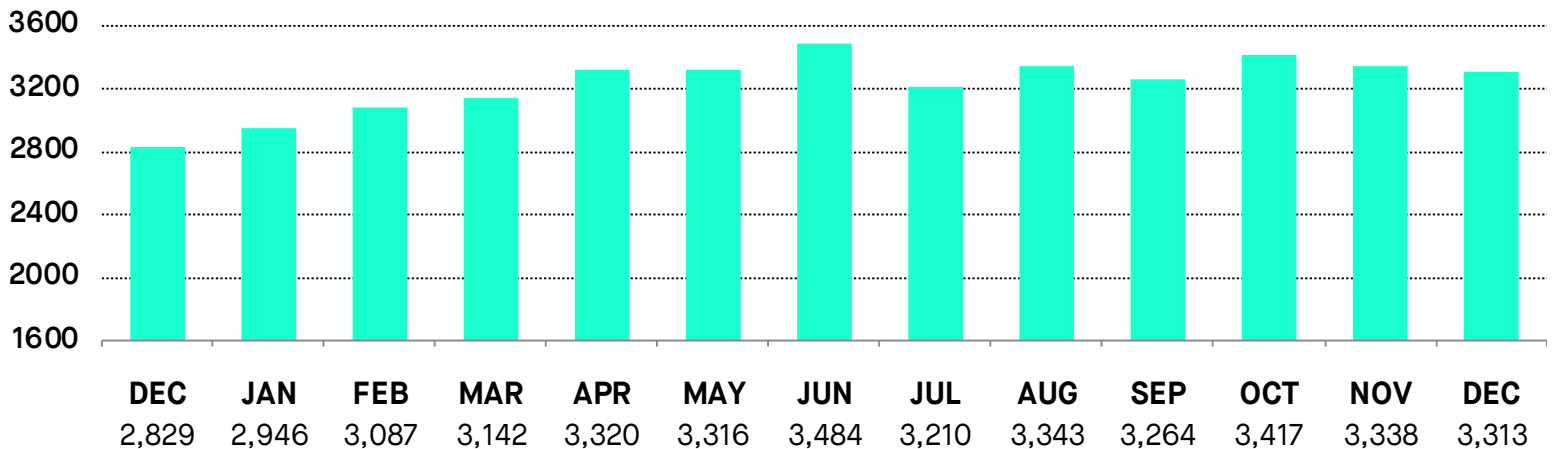
JAMAICA STUDIO PRICE TRENDS OVER 13 MONTHS

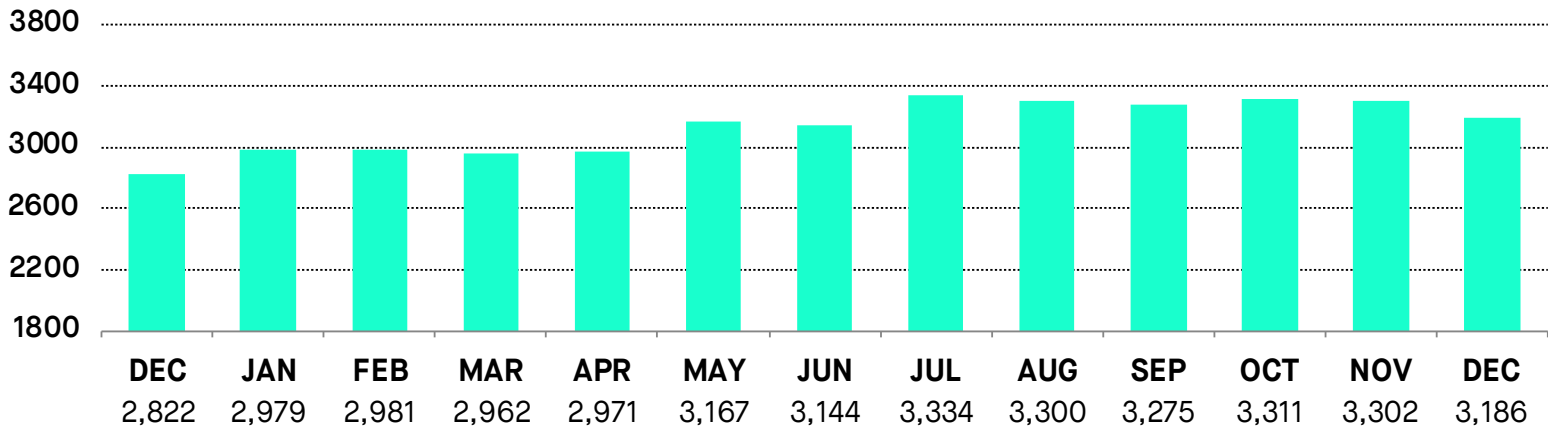

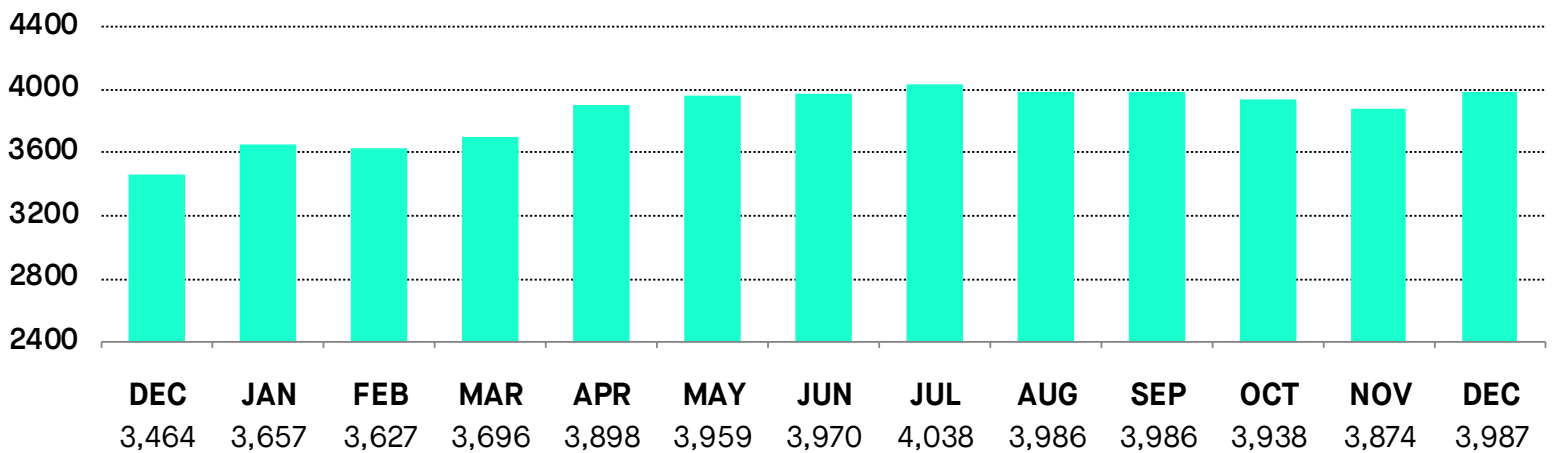

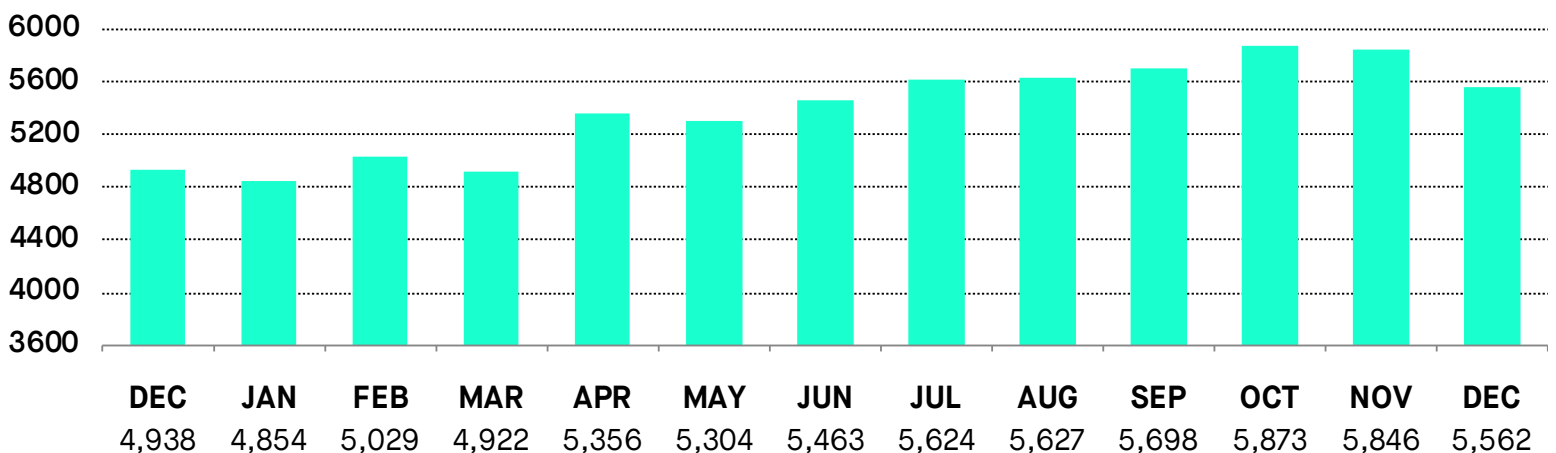
LONG ISLAND CITY STUDIO PRICE TRENDS OVER 13 MONTHS

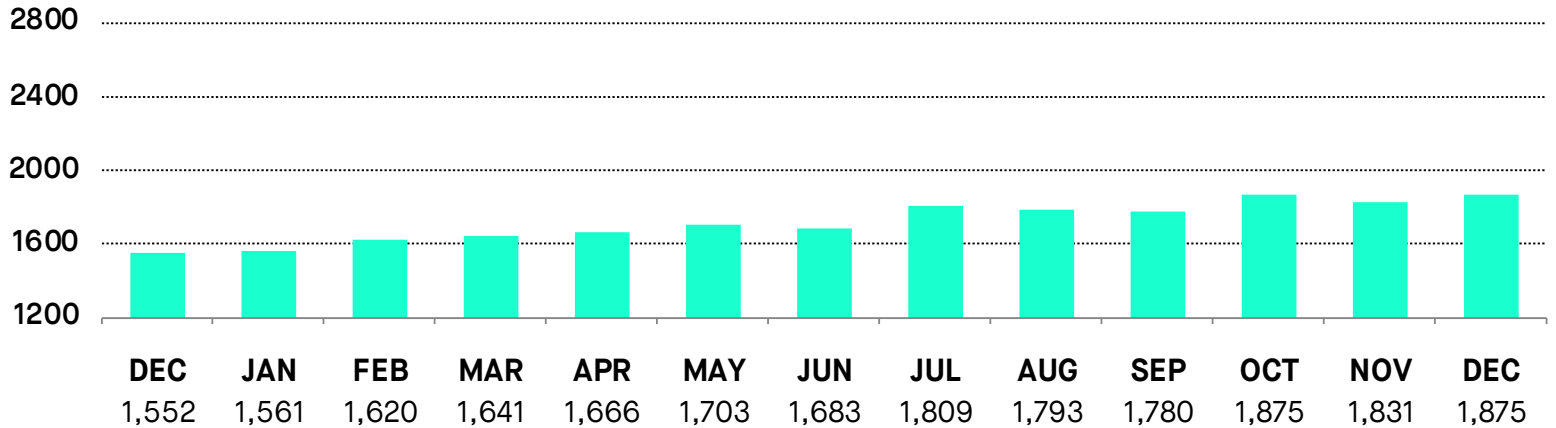

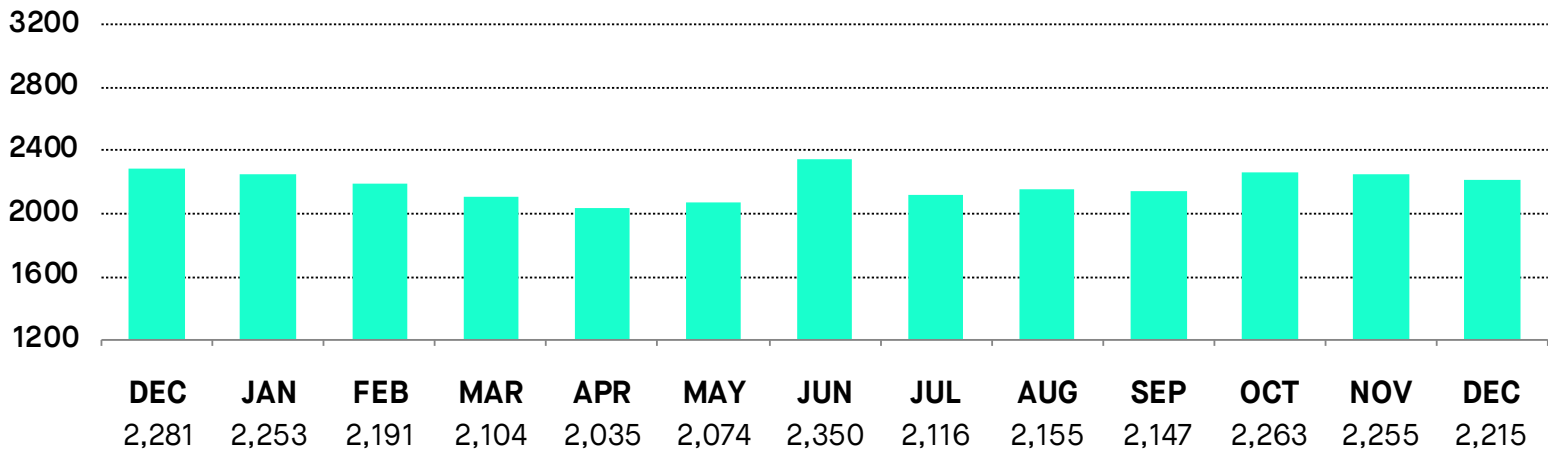

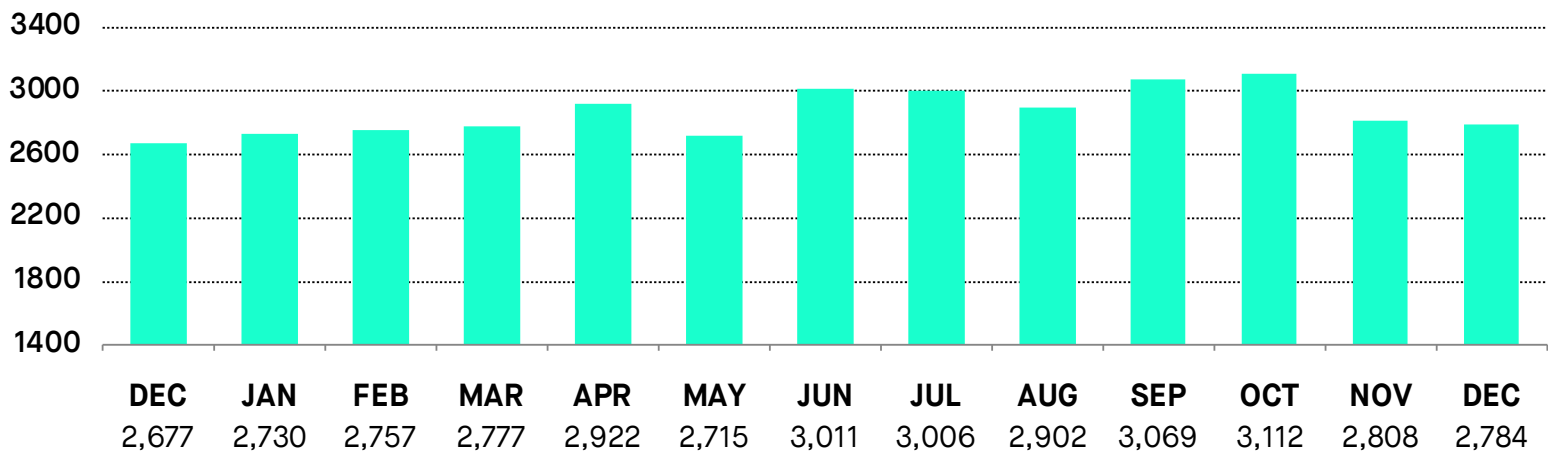
REGO PARK STUDIO PRICE TRENDS OVER 13 MONTHS



REGO PARK ONE-BEDROOM PRICE TRENDS OVER 13 MONTHS



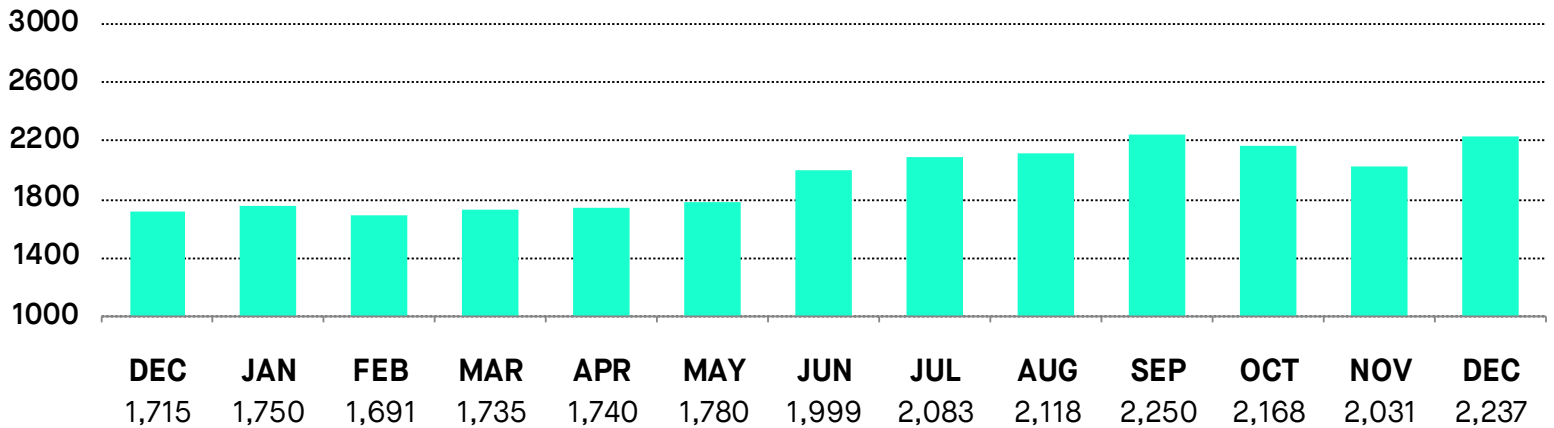
REGO PARK TWO-BEDROOM PRICE TRENDS OVER 13 MONTHS



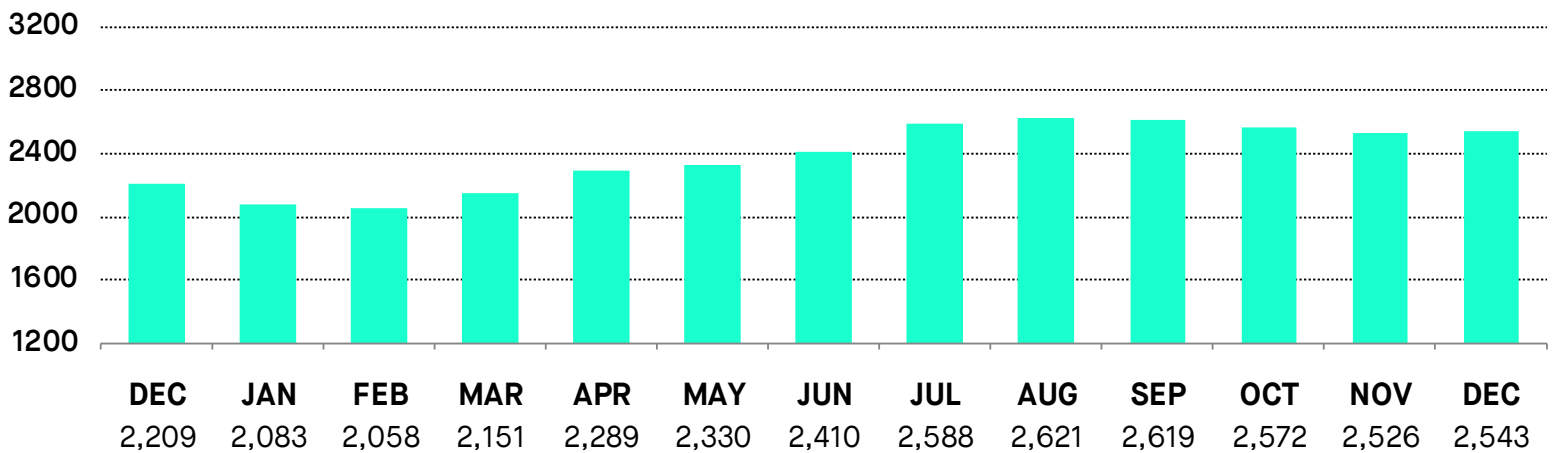

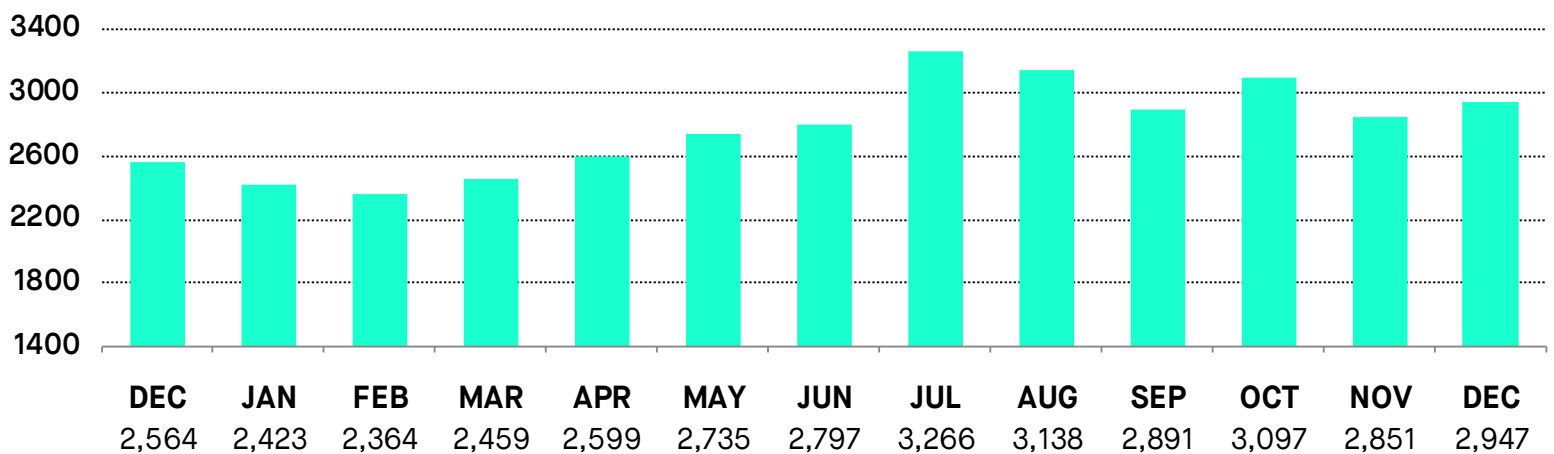
RIDGEWOOD STUDIO PRICE TRENDS OVER 13 MONTHS

The Queens Rental Market Report TM is based on a cross-section of data from available listings and priced under \$10,000, with ultraluxury property omitted to obtain a true monthly rental average. Our data is aggregated from the MNS proprietary database and sampled from a specific mid-month point to record current rental rates offered by landlords during that particular month. It is then combined with information from the REBNY Real Estate Listings Source (RLS), OnLine Residential (OLR.com) and R.O.L.E.X. (Real Plus).
